95.5 NASH ICON'S "AARON TIPPIN WEB" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WSM-FM ("Station"), owned and operated by Cumulus Broadcasting LLC, 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday, on the Station website www.955nashicon.com, or by sending a self-addressed, stamped envelope to the above address.

All entries must be received by 11:59pm CT on April 20, 2025, to be eligible for the Prize drawing.
